2016 Moderator's Survey of Town Meeting Members – Comments, Text Field Answers

Q1 Overall Satisfaction - additional comments

- 1. Many Town Meeting Members fail to question the overwhelming unanimous votes of the BOS and the financial committees. This rubber stamp activity is not conducive to good governance.
- 2. Inordinant amount of time on certain articles, eg, the roof repair to Muzzey
- 3. Too many sessions from start to finish.
- 4. As usual we spent way too much time on trivial budget matters
- 5. The only downside was the poor pre-presentation work done by the sponsor of the gun control article. As I said in my remarks before Town Meeting it could have been done far better and in a way that did not cause the overreaction of things like metal detectors at the entry points. Other than that it went smoothly with no wasted time.
- 6. The best there is to it
- 7. would prefer that no amendments be made or considered on articles on TM floor.
- 8. The Moderator's oversight of Town Meeting was superb in every way. That said, the length of presentations, particularly by Town staff/elected officials/interest groups was painfully long with hard to follow and read Power Point presentation after presentation. Lexington should consider taking a page from its neighboring communities, by limiting the length of these presentations (less than 10 minutes), the size of typeface allowed, graphics allowed, etc. Also, we all appreciate the work of Town Staff but is it appropriate to take a recess in the middle of an already too-long TM to have Town staff give speeches about other staff? TMMA notice that an appreciation event will be held for whoever is retiring should be enough. No other neighboring community has Town Meetings which run on for months. The bottom line/impact is that the current length of Lexington TM discourages anyone for running for TM, who has a full-time job outside of Lexington, and needs to be at work by 9 am the next day.
- 9. It would be beneficial if the sound system could be tweaked so that it "worked" without having to remind every speaker how to hold a microphone. Since this was my first year as a TMM, I have nothing to compare it to. I do believe that the Moderator handled the meetings in a very professional and courteous manner.
- 10. Very smooth sailing. Even the more contentious articles where well handled.
- 11. First of all, the event as a whole was simply too long. The many Special Town Meetings, both before and during the Annual Town Meeting, created complications and time pressures that reduced the ability of Town Meeting to function properly. In addition, the large number of zoning articles made for an onerously long and complicated list of Warrant Articles.

- 12. too much time spent for too little action.
- 13. Would like more advance notice when special town meetings are being considered, let alone scheduled.
- 14. Very satisfied with moderator but found it somewhat mystifying that there was larger debates for smaller or less expensive items while larger investment decisions generally went with smaller discussion times.
- 15. I'd recommend having an electronic vote if a TMM calls the question instead of a voice vote.
- 16. Consent budget is the best.
- 17. The same people jump up to mike on almost every article. There should be a way for moderator to NOT call on people in order, but let others speak first?
- 18. The sessions were sometimes very long, requiring intensive reading preparation. Even at the cost of holding more meetings, it might be helpful to slow the pace.
- 19. Just too darn many sessions running in to May! Can't we be more efficient? Too many special town meetings interfered with annual town meeting as well.
- 20. There were slight technology glitches and that took some time in some meetings. rest was great.
- 21. The articles should be addressed in the order in which they are placed in the warrant. Way too much jumping around this year.
- 22. well run

Q2 Documents and Presentations

- 1. Unfortunately, timing is always the problem for committee reports. They are forced to play last-minute catch-up.
- 2. Municipal Capital projects need to be explained in the presentation, not just the amount of money, but how and on what it is being spent. The School projects were better explained.
- 3. This is the second year of lack of verbal explanation.
- 4. I wish that these reports were evidence based and available at an earlier time.
- 5. The most important ones to me are the Moderator's Schedule of Articles, the Capital Expenditures report, the remarks by the Town Manager and the remarks by DPW/Engineering, Facilities, Recreation and other Town staff.
- 6. Some documents were more helpful than others. I found the CPC's reports to be minimally helpful. They should have been much more prepared to answer questions or make sure someone was available to answer questions regarding the Antony Park project and its history. That one left me feeling a total lack of transparency by the town.
- 7. Planning Board presentations and materials offered were exceptional.
- 8. Supported the school budget & like the Superintendent, but her remarks not very helpful.

- 9. Although the large printed books (such as the 'brown book') are too detailed for me to read thoroughly, they are helpful to reference specific issues. As an older member, I prefer the printed material rather than trying to read online.
- 10. The sheer number of reports was overwhelming. I also renew my objection to the way the CPC presents its items. They have to consolidate some of their reports into group summaries, and they need to adjust their length in relation to the amount of dollars being appropriated.
- 11. Some speakers are clearer (and more audible) than others, and some article sponsors were not very well organized, but on the whole I look forward to the presentations because they are illuminating and helpful.
- 12. Written comments from the BoS would be helpful. CEC verbal comments have strayed away from financial impact of capital projects and relative prioritization should be more focused on helping us understand the readiness and financial consequences
- 13. The quality of the written materials and presentations by article sponsors really varies. These materials should probably be vetted before distributed. For example, the statistics on gun violence were not really on point should have been tailored specifically to the assault weapon ban. Also, sometimes the materials presented layout the general issues and ideas of a proposal but fail go to into enough detail about the budget or rationale for some of the projects. (ie for community preservation, we know that there are lists of projects, but it's unclear why certain projects are prioritized vs. others).
- 14. When we take a vote and there are some dissenting votes from a committee, I would like to have the dissenting opinion(s) explained.
- 15. Varies by sponsor
- 16. I was very disappointed in the TMMA booklet this time. I have always found it most helpful in the past but this year it was late and sketchy.
- 17. I like to hear what the various committees think about the different articles.
- 18. Presentation should not repeat everything from TMMA sessions. Slides should have bullet highlighted, not so detailed to be read by presenter.
- 19. Maybe we should go more paperless. If a town meeting member is going to read a very thick document, that person can read it on-line too. That way paper costs are eliminated.

Q3 TMMA Activities and Resources

- 1. Warrant Info Book has often been a valuable resource but this year it was too little, too late.
- 2. I don't like the fact that any citizen has complete access to the TMMA email list by involving a Member. I feel that this is not a proper use of the list.
- 3. I continue to find bias in the TMMA Info book, which reduces it to an internal lobbying effort. Because of this, I generally do not use it.
- 4. TMMA Info Book was released too late and in pieces, so it was less useful than usual.

- 5. It is unfortunate that perhaps half of all TMMs attend the bus tour and the information sessions. A lot of material has to be repeated during Town Meeting. I go to the bus tour and the information sessions to get a sense of what is going on. I find it very useful in preparing for Town Meeting. The e-mail list, like all lists, is not terribly helpful. Too much argument, not enough information.
- 6. So many TMMA members do not come at the meeting, need to find out why. Sometimes the TMMA members get the information from other sources Little late!!
- 7. Not sure why the TMMA Info Book is compiled it really is extraneous and not needed.
- 8. I believe rules for the email list should be revised to discourage individuals from saying how they are going to vote before we get to town meeting. The list should be used primarily as a resource for asking questions, and getting answers, NOT as a pre-town-meeting forum for expressing opinions. The TMMA information book has clearly become a burden that a few people manage, while the majority of TMMs just don't have the time. The result is minimally helpful information and a huge waste of paper. This should somehow be transformed to an online system or some other vehicle for summarizing the articles should be conceived.
- 9. I believe that the TMMA information book has outlived its usefulness. Information sessions and bus tour are useful.
- 10. The way the TMMA Information book was presented; that is in pieces and sometime at the meeting where the topic was being covered was a problem. We need it in one piece and before the first session.
- 11. The Warrant Information report was not good this year. More people volunteering to help is needed.
- 12. Given the timing of the Warrant and the late action from many Town boards and committees, along with the general lack of volunteerism with the TMMA, I think the TMMA Information Book should not have been published this year.
- 13. TMMA information sessions often seem a bit redundant, given the abundance of material online and in print, and then offered in almost the same form at Town Meeting.
- 14. TMMA info book has been great in the past, last year not so much, this year very fragmented and late
- 15. Info book should be done only online and in a wikipedia style, with people able to post info and/or pose their own questions to help presenters better prepare.
- 16. TMMA info book could be limited to non financial articles Capital and Appropriation Committee cover the financial articles and have more depth/expertise to share.
- 17. TMMS information book (in several sections) was not as helpful as a single book.
- 18. The TMMA information book was not as effective this year as it has been in years past... I found the issuance in parts confusing, and didn't see the same in-depth analysis as in previous years. (I understand there were staffing constraints)

- 19. I was unable to attend the bus trip this year but I usually find it helpful.
- 20. The meeting sessions following in-person information sessions tend to be repetitions of the information sessions. Information given at full meetings could be more compressed. Unfortunately I had to miss three meetings when I was away at a conference so missed the benefit of some of these resources. They were generally helpful.
- 21. Re: the emails I would prefer significantly less "snark" in the exchanges. I often find the tone dismissive and disrespectful and as a consequence, off-putting.
- 22. I stopped attending the TMMA info sessions, because they were so repetitive of what we hear at town meeting anyway. The TMMA info book is truly a waste of resources. The only instances where it might be helpful are with regard to citizens articles as to which none of the standing committees makes a report. Otherwise, the standing committees are much better positioned to issue reports.
- 23. I would prefer to get "official" town meeting info from the town clerk, not TMMA.
- 24. Should not be allowing debate over TMMA email.

Q4 Information Quantity and Quality:

Reflecting upon all of the information available to assist your decision-making at Town Meeting, please share any additional thoughts you have on:

- The quantity and quality of that information,
- Whether the information was helpful, or
- Whether something could be changed in some way to make the information more helpful.
 - 1. All materials were helpful and appreciated
 - 2. Information was generally helpful.
 - 3. Municipal Capital projects need to be explained in the presentation, not just the amount of money, but how and on what it is being spent. This is the second year of lack of verbal explanation. High value projects (+\$100,000) need to be questioned to tease out unforeseen issues that my arise during implementation. TM is a 'fresh' set of eyes, whereas working groups/committees have been close to the projects from the beginning and may have tunnel vision.
 - 4. We need to have more independent thinking from the "sheep" in Town Meeting who never question the leading committees, boards or staff. After all it's our money. We hear too often that Lexington is a "well run town" and focuses on our credit rating and not how we spent our money.
 - 5. The information is mostly very helpful the discussion by various Town Meeting members is always very helpful in making my decisions.

- 6. Warrant info book far inferior to prior years.
- 7. See answer to question 3.
- 8. Late breaking availability of information may be unavoidable but it is the biggest problem. When we got it it was of good quality.
- 9. it often felt that information was late and rushed, making reasoned decisions more complicated.
- 10. I read the reports in order to make my decision on voting.
- 11. The School Com should have weighed in more on the decision to purchase the Armrnian Sister's school and disclosed to TM the dysfunction between the Head of the School Com and the Superintendent. Also, we need to address the benefits/risks of keeping the METCO program and if we keep it, getting the State to fund more of it. We need to document that every student is a resident and not getting a great education, when not playing by the rules.
- 12. I thought that the information was comprehensive and helpful.
- 13. There is excellent information available on the Town web site and from the finance committees. TMMA sessions are not well attended and are often redundant. The TMMA information book generally adds little information, and given the difficulty in getting volunteers to write it, could be discontinued.
- 14. It took me awhile to figure out something that not all TMMs understand and that is that staff cannot effectively champion an issue. That is up to the proponents of the article so those proponents must do a good job in presenting the issues and why we should all vote Yes. Staff is there for information so we have to ask intelligent questions and we need to do some serious homework and not depend on just attending the Town Meeting sessions.
- 15. Article sponsors who present to TM need to be informed of best practices regarding printed and projected information.
- 16. The document table is disorganized. It is hard to know what is old and what is new despite the "NEW" sign. Could the tables be separated so that NEW materials are distinguishable by location?
- 17. Sometimes the information is duplicative. One to let folks know one presented at the town meeting
- 18. quantity and quality was sufficient
- 19. Feel like we are wasting an awful amount of paper--perhaps an easier way to view documents online via the wifi?
- 20. I thought the quantity and quality of the information was fine.
- 21. The info sessions are the best way to get the needed info.
- 22. There's too much information, but I have no suggestions about how to separate the wheat from the chaff.

- 23. There is always a crowd before every session to get all the materials and handouts for the meeting. Many times (in order to not hold up the line) I end up re-taking handouts from previous days and then sift and sort through them during the meeting. Can we put prior materials on a separate table?
- 24. Quantity can easily be cut back without affecting quality.
- 25. I found the Information Booklet helpful as it was broken down in small bites (articles) when they were being presented. Quantity / Quality was fine and helpful.
- 26. More transparency, e.g., on assumptions built in about future expenditures, would be helpful with budget presentations made by Board of Selectmen/Town Manager. Also have great concerns with policy which assumes full tax levy will be used every year in annual budget.
- 27. The bigger the amount the less information provided such as for personnel costs and pension costs.
- 28. Context is important. It is very disappointing that there is no long- term financial planning to provide a ocontext for Town financial needs.
- 29. A 5-year plan and a 10-year plan (or at least a 3-year plan and a 5-year plan) would be most helpful. And they should be updated annually. Why do they not exist?
- 30. Good quality & quantity. I continue to be impressed by the amount of volunteer time expended. Planning Board hit the ball out of the park. Agree or disagree, I knew what I was voting on.
- 31. It was all helpful.
- 32. It is sometimes overwhelming.
- 33. The quality of the info was generally very good. The volume sometimes seemed overwhelming, but it's hard to think of any way of avoiding that.
- 34. Projected presentations are too often unreadable, with type too small and too much on a page.
- 35. I can hardly remember what happened at Tm this year. It would be more helpful to send this out as soon as TM is over
- 36. I believe that the quality of information was generally very good.
- 37. Perhaps due to the quantity of articles, the TMMA Information booklets were not always distributed in a timely fashion. Perhaps making them available online rather than in print could be considered. Generally, the information found in it (them) is useful. Information sessions: While I find information sessions useful, they are not well attended. I wonder how we might get a "preview" of the articles without asking town officials and other presenters to give another evening to the public, since the same information is presented at Town Meeting. If such information sessions continue, it is important for whoever

- "moderates" them to ensure that they are just that: information sessions, not open to "debate."
- 38. I am just blown away by the fact that the Town Manager stated we collect only \$10,000 in rent per tenant per year at Munroe Center. Who gets to fix that amount? Why?
- 39. Often the written material was presented too late. That is when presented the night that the topic was cover. I don't have time to review it. When presented by email it should be at a minimum the day before the meeting.
- 40. TMMA info book was less timely, comprehensive, and helpful than typical in the past.
- 41. I felt that there were many difficult decisions this year. I think that there was enough information to help make decisions.
- 42. The TMMA information sessions are helpful to get preliminary details about various articles, but should be kept short so they don't substitute for TM discussion.
- 43. You can lead a horse to water, but you can't make him read the reports. We had a whole lot of questions from the floor that were very clearly answered in the available reports. We seem to be lacking two things: the motivation to use the available information in the first place, and (perhaps) an overall framework of information that would make it easy to find answers in advance.
- 44. I'm not a finance person, and the budget books are frankly incomprehensible to me. But I'm probably in the minority on this.
- 45. The distribution of printed material can be improved. It is not apparent which items are new, are updated or pertain to that evening's presentation. I end up with duplicate which just leads to clutter. All materials should be dated.
- 46. Presentations posted online in advance.
- 47. The quantity is always overwhelming. It comes down to reading the first and last sentences and then first and last paragraphs.
- 48. I think the use of technology will be useful perhaps get rid of paper that is generated quite a bit
- 49. quantity of information was too high
- 50. Same as above. Committee reports on votes including both why "yes" and why "no."
- 51. Generally helpful
- 52. Keep the TMMS info booklet in one edition, even if it's a week late. Less confusing.
- 53. Have a uniform means to convey the date of a given handout. Colors hlep, but so would clearly legible dates.
- 54. Too much information! Difficult to read everything when one has a 50 plus hours/week job.

- 55. I'm not always sure where to access materials online. But this could very well be an oversight on my part.
- 56. This was my first year as a TMMA and I found the information very helpful.
- 57. Overhead charts are sometimes unreadable. Mikes still do not work well
- 58. As a rule most information was helpful though sometimes a bit repetitious. When information is presented I really appreciate when it is projected onto the screen. My "learning curve" works best when I can view the information. This need not be extensive but should outline the basic issues.
- 59. Collated booklet for each week's business might be more useful than segregating information by committee / board.
- 60. I think Marge's (and now Deborah's) comment that everything may have been said but not by everyone should apply to the TMMA listserv as well YES it's very easy to delete. But I wish people were a little more thoughtful before they hit the send button
- 61. Generally helpful.
- 62. Some of the pre-town meeting information was redundant, especially the info sessions.
- 63. This is hard to answer in general. On specific articles there was a info I wish I had, but I was not shy about using the question microphone for that purpose.
- 64. I would prefer to have the town clerk post all relevant info on the town website at least 48 hours prior to when each article is scheduled. Having to locate a motion printed and left on the table two weeks or longer BEFORE the article is presented just doesn't work.
- 65. I continue too be impressed by the engagement of citizens in the process and their willingness to share their opinions. More listening to those with different perspectives should be facilitated by the moderator.
- 66. Just fine

Q5 Consent Agenda

- 1. It's an excellent time-saver!
- 2. To pull an item from the agenda should be changed from 1 deserting member to a majority vote.
- 3. Excellent idea. Conserves time and energy.
- 4. I think the ability to withdraw an article from the Consent Agenda is a reasonable safeguard against anything accidentally getting by. I think it is a good idea.
- 5. There should be more on the consent agenda
- 6. good idea
- 7. Too much opportunity to slip in an issue that should receive closer examination.

- 8. I'D LIKE MORE ITEMS LISTED ON THE CONSENT AGENDA. We still seem to spend more time on items inverse to their budget impact. 10 minutes on the school budget and an hour on something that might be \$50,000, and the the 140-5 vote in favor.
- 9. Have wished for explanation on some IPd articles, but I think they weren't on the consent agenda. Can't remember.
- 10. Good idea!
- 11. This has worked well and saved us time.
- 12. The consent agenda should be used annually for those articles that normally get approval every year.
- 13. Very helpful to get quickly through many articles that will get unanimous support. Saves much time.
- 14. Please formalize a maximum dollar cap for items on the Consent Agenda.
- 15. An innovative idea, very efficient and time-saving!
- 16. Certainly saves time.
- 17. Wonderful!
- 18. Absolutely!
- 19. Use of Consent Agenda is effective.
- 20. The consent agenda is a good innovation so long as members can easily take items off if they wish to do so.
- 21. They are valuable in saving time while allowing for further discussion as desired.
- 22. More could be added, given that many votes were virtually unanimous.
- 23. Add more items as many as possible to the consent agenda!
- 24. However only for truly routine business. There is a tendency for some till think their is broader consensus. Even when that is true it gives the illusion that only concurrence is tolerated.

Q6 Moderator's workshop for new Town Meeting Members

- 1. We have an excellent Moderator, who is very close to perfection. I do think that our Moderator should see that membership on a finance committee is not a lifetime appointment.
- 2. It has been awhile since I attended a new member workshop and I missed the one three years ago I wanted to go to when I went from a BOS member to a Pct 9 member. But I think the idea of a workshop is a good one. I plan to attend before the next spring Town Meeting just to see what they are like now.
- 3. I did not attend. But I know that they help new TMMs.

- 4. As a presenter at these workshops, I feel that it's a very disorganized and haphazard introduction to TM. I suggest limiting the number of presenters to three, each with roughly 20 min. of material.
- 5. How about pairing new town meeting members with a veteran mentor for their first year as a town meeting member. I think we don't give enough opportunities to reach out to new members and they sometimes feel they are outsiders. A mentor could provide a new model for inclusion.

Q8 Process and Parliamentary Procedure

- 1. I especially like the workshop and mentor ideas.
- 2. I think both the workshop and the review before each Town Meeting are wonderful ideas -- and even those of us who think we know everything can always learn more!
- 3. N/A
- 4. These may be helpful to new members. Should be second nature to old members. It would distract from conversations about actual meeting business if held in the hall before the meeting.
- 5. I think a TM mentor is a great idea. When I first joined, several of my peers were also new and we had an unofficial mentor (or two) who met with us as a group and it was incredibly helpful.
- 6. Hmmmmm. Not sure. The idea I like best is the 7:15-7:30 mini-workshop. I think one of the best bridges over knowledge gaps is that the Moderator typically explains, in some detail, what is going on so one never has a chance to say "I had no idea and I just missed that completely."
- 7. Every new member should be assigned someone in their precinct who can answer questions.
- 8. There are questions posed by citizens and even me. How can citizens submit their agenda for including in town meetings process and systems maybe we should make it easy -- printed information after town elections
- 9. I have helped TMMs on procedure. I am available anytime during TM to help with procedure. Glad to help.
- 10. Workshop might be helpful. Mentor seems a bridge too far.
- 11. All 8 ideas are Great ideas
- 12. Reviewing parliamentary procedures at the opening of Town Meeting (first session) is useful, but is not necessary at each session. Most if not all of the procedures can be found in the booklet "Town Meeting in Lexington." Referencing that booklet from time to time might be worthwhile.
- 13. After a number of years in TM, I understand this pretty well.

- 14. TMMs need to learn parliamentary procedures, I see no need for reviewning it every night before TM.
- 15. I'm pretty well versed on the procedures, but would be happier if more of my colleagues were comparably informed.
- 16. I have been a member for 3 years. In that time, I feel that learned what I needed to know as issues arose. I relied on other members from my precinct to explain things I didn't understand. I think the idea of a mentor might be helpful for new members.
- 17. A workshop would allow Q&A and interactive discussions on topics and thus be more helpful than just watching a video.
- 18. The most complicated procedure that we have to execute on a routine basis is amending a motion. Some kind of video summary might help. More useful would be a dynamic visual indicator on the big screen of where we are in the amendment process (what is being debated? what is being voted on? what has already been approved/disapproved?).

- 1. The article discussion related to the gun control issue was not managed as well as I had hoped. Specifically, I was not comfortable with the comments of the police chief which for me bordered on being inappropriate. I had trouble distinguishing between staff as advisors and as directors and I felt that those aspects of a difficult discussion could have been better managed by the moderator.
- 2. I wish this survey had been sent out immediately after TM ended. The whole TM experience would have been much fresher in my mind.
- 3. I did feel like this year's TM voted on some important issues and I was proud to be able to participate in the process.
- 4. Town Meeting and some of the professional staff looked very bad in the way they dismembered Bob Rorberg's Article, short-circuiting any real discussion. Non-residents had free reign to tell Lexington how to run their town. This was the worst I have ever seen in all my years as a TMM. The fear was palpable and sickening.
- 5. This is the second time I have submitted this data. Hope it connects this time.
- 6. Please continue improving the sound system.
- 7. Usually presenters are singing to the choir or preaching to the already converted. If we know a Yes vote is likely and if TMM have availed themselves of the multitude of informational resources, prior to the vote, there is no need for so much debate. I feel hostage to the few TMM who have a need for their voice to be heard, over and over. I think the School Com should behave done a better job of being up front about several issues, redistricting, the overpopulation crisis and the short or long term solution, the internal controversies, etc. I think they need an expert to help them all get along, to better serve the town or the head should resign.

- 9. I wasn't very pleased with Selectman Kelley speaking on Article 10g, the East Mass Ave easements, as he spoke not about the easements, but about the project as a whole. He was given a platform to go on at length in opposition to a project which had already been approved which was not appropriate.
- 10. I'm a believer in the process of citizen review. Town Meeting can be slow and even tiresome at times, but I see no better way of directly involving citizens and encouraging them to become knowledgeable about the way the Town is governed.
- 11. I think we are moving to a multiple-town-meetings-per-year model, but unlike some I do not disagree with that. Nebraska has a unicameral which used to meet just two months per year until early in the 1970s. As a result, important issues were ignored and by the time they were acted on, it was too late. Moreover, Lexington used to have multiple one-night

- sessions in the distant past. Unlike some who decry the extra time they must spend in Battin Hall, I think that dealing with things as they come up is a good idea and the idea of more than one or two Town Meetings per year makes sense to me.

- 25. Question 19 is what I'd like to comment on. I will have to make a decision later this year about whether to run again for a fifth term as a Town Meeting Member. While I enjoy being a Town Meeting Member, the obligation in terms of time and commitment is becoming greater each year because of the Special Town Meetings. Furthermore, I find myself more and more often in disagreement with some of the decisions being made by TM. I am frustrated with the recommendations and decisions being made on parking in the center, additional traffic lights, center sidewalk projects, etc. I believe we're on track to do serious damage to what remains of the central business district. I was in Signature Stationers today and got an earful from the owner of that store who says the new meters on Massachusetts Avenue coupled with the cost of rent and the taxes are literally making it impossible to stay in business. I personally shop in the Center less often than ever before. I bank and shop where parking is free -- Waltham and Arlington.

- 26. While I realize the gun article was a hot topic, I thought the preparation was a little extreme with the metal detectors and the like.
- 27. Way too much material is printed all TM materials should be available online, and if someone wants a printed copy they can do so themselves.
- 28. The rotation of where we sit each session is a pain we should sit in the same rows every session instead of moving around.
- 29. Please have recycle bins clearly marked at exit of the hall. We waste a lot of paper!
- 30. I am available to help in any way and at any time.
- 31. Two comments:
 - 1) The question was called for the immense School Capital project when an opposition speaker appeared at the "no" microphone, the first one. I wanted to hear what she had to say, but she was denied the opportunity to speak.
 - 2) WRT amendments: the "no surprise" rule is good---I'd argue almost necessary---but making a reasonable amendment from the floor seems to take too much effort and time. Any way to streamline that would be appreciated from maker's and bystander's perspectives, both.
- 32. More readable slide presentations.
- 33. I would very much like to explore any additional options to streamline Town Meeting.
- 34. The Town boards and committees do an excellent job presenting information and analyzing articles that come before Town Meeting. The quality and thoroughness of their written and oral presentations is remarkable. The moderator is at the "top of her game" and does a fine job in all respects. The sound system is not entirely adequate for the job! The number and length of sessions sometimes "irks" me! Otherwise, Town Meeting definitely fulfills its mission in Lexington.
- 35. I don't understand how most TMM's seem to vote yes all the time. Do they think about the taxpayers who have elected them to office?
- 36. It would be helpful if the power point presentation were made available in advance
- 37. Still some glitches to work out with regard to both the sound system and the voting system, but generally a well-managed TM.
- 38. OUTSTANDING job in managing the gun article. Other towns could learn from the demeanor explained and expected by all that evening.

- 43. Community Preservation Committee should do a better job of explaining how they determine the total amount of money they expect to receive.
- 44. Can the warrant include a sentence or two in plain English about what each article actually means? Might help people recognize issues of interest/impact. The language is just not accessible to a lot of people.
- 45. It is very frustrating when the Zoning board does not uphold the decisions of town meeting. 7 foot ceilings in the basement were discussed, but were never considered on upper floors as a way of reducing floor area ratio. It is inexcusable that builders were allowed to exempt square footage from the floor area ratio by keeping upper floor ceiling heights at 7 ft. This was not what Town meeting voted.
- 46. I thank you all for the excellent work that you do for the Town.
- 47. Thank you!
- 48. My memory is not so great that I can accurately remember details from March and April in July. That means that my above answers are rather clouded by the passage of time and are not nearly as valuable as responses that would be made within a few days after each Town Meeting session, especially in regard to what was or was not helpful for the articles that had been voted on and how effective my participation was.
- 49. I was unhappy with "calling the question" on the gun issue. Moderator had set aside a whole session to hear all opinions. If such an important issue comes again, can the Moderator state, "I will not entertain a motion to cut debate short until (a time certain, such as 10:00 PM)"?
