Transportation Registration Form 2011 – 2012

All students (Town paid eligible & fee based riders) requesting Transportation must register for a bus pass.



Registration forms and full or 50% payment must be received by May 27, 2011. Registrations received after May 27, 2011 will be processed providing payment is made in full and there is available space. Bus routes and stops will be similar to 10-11 routes and adjustments will be based on data received by the deadline date of May 27, 2011. Please note that the Transportation office cannot guarantee transportation for applications received after this date for any student; Town paid eligible or fee paid riders.

Payments and registrations received after May 27, 2011 will not be eligible for the Early bird price.
